III. APPROVE PREVIOUS MEETING MINUTES

IV. FINANCIALS

- A. Deb reported on the financials as of December 31, 2020 fiscal year-end close as follows:
 - a. December 31, 2020 close financials report that Farmers Grove has \$1,304.51 in Operating and \$114,037.81 in Reserves.
 - b. The Profit and Loss reports that as of December 31, 2020, Farmers Grove is \$463.38 over budget in operating expenses.
- B. Deb reported on the financial report as of January 2021 close as follows:
 - a. January 31, 2021 close financials reports that Farmers Grove has \$3,594.09 in Operating and \$115,220.72 in Reserves
 - b. As of January 2021 close, the HOA was \$949.80 under budget in Operating expenses.
 - c. The Board discussed the major areas of variance.
 - d. All owners who are not paying dues are being assessed late fees.
- C. 2021 Capital Plan Allocations
 - a. Crack fill and seal coat \$13,000 allocated
 - b. Signage \$300 allocated
 - c. Landscape \$1,500 allocated

V. MANAGING AGENTS REPORT

- A. Completed Items
 - a. Placed temporary no parking sign by mailboxes. A permanent one will be placed once the ground thaws
 - b. Continued communication with owners regarding dogs
 - c. Playground maintenance complete

- B. Pending Items
 - a. "No Parking" sign needs to be permanently installed
- C. Report Items
 - a. Vole baiting will continue in the spring. The contract is for 6 months.
 - b. One owner is very late with payments and an attorney has been contacted to place a lien on the property.

- A. Annual Disclosures
 - a. HB 1254 Per Colorado Legislation, SRG presented the annual Management Fee Disclosure to the Board.
 - b. 2021 Disclosure as required by CCIOA it was noted that the "Annual Disclosure" of all HOA documents is completed multiple times per year. This is accomplished by way of multiple mailers to all Owners throughout the year (to include within 90 days of the fiscal year), stating that all HOA documents may be found online at the HOA's website.
- B. Spring Drive Through The spring drive through will take place when it warms up. Once a date is set, Owners will be notified via email.
- C. Insurance On April 1, 2021, insurance for the HOA renews. SRG has shopped the market and the Farmers policy continues to be the most cost effective while offering the best coverage. It was noted that there is a 10.7% decrease in premium for 2021. Val made a motion to approve the insurance as presented. Alex seconded, and the motion carried.
- D. 2020 Tax Return The Board approved the 2020 tax return and SRG will sign on behalf of the board.
- E. 2021 Tree and Turf The board reviewed bids for tree and turf spraying for this summer. Val made a motion to hire Ascent Tree and Turf to complete the work. Alex seconded, and the motion carried.
- F. 2021 Landscaping The board reviewed bids for landscaping. Val made a motion to hire Greenscapes to complete the landscape maintenance this summer. Alex seconded, and the motion carried.
