LIMITED AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF CAMPFIRE MOUNTAIN HOMES ASSOCIATION

RECITALS

- A. Three Rivers at Keystone, LLC, the original Declarant, created Campfire Mountain Homes Association by recording a Condominium Declaration for Campfire Mountain Homes in the real property records of the County of Summit, State of Colorado, at Reception No. 596750, on May 27, 1999 (the "Declaration").
- B. The Declaration provides for and allows for this Limited Amendment to the Declaration (the "Amendment") in Article 21, Section 21.2, which provides as follows:

this Declaration (including the Map) may be amended only by a vote or agreement of Owners to which at least sixty- seven percent (67%) of the votes in the Association are allocated.

- C. All Owners are aware of the provisions of the Declaration allowing for amendment, by virtue of the record notice of the Declaration, by acts and disclosures, newsletters or notices of the Association and by other means.
- D. This Limited Amendment has been prepared and determined by the Association and by the Owners that have approved this Limited Amendment to be reasonable and not burdensome.
- E. The purpose of this Limited Amendment is to re-designate certain portions of the Common Elements as Limited Common Elements as related to deck expansions.
- F. The undersigned, being the President and Secretary of the Association, hereby certify that Owners representing at least 67% of the Association votes have consented and agreed to this Limited Amendment.
- G. As amended by this Limited Amendment, this amendment shall become part of and incorporated into the "Declaration" (the definition of Declaration includes plats and maps).

- I. Amendments. The Declaration is hereby amended as follows:
- Repeal and Restatement. The Limited Common Element Deck attached to Unit 9, as depicted on the Condominium Map of Campfire Mountain Homes-First Supplement, recorded at Reception No. 601558 in the Summit County Clerk and Recorders office on July 29, 1999 is hereby reconfigured as generally depicted in Exhibit A. attached.
- (b) Repeal and Restatement. The Limited Common Element deck attached to Unit 11 as depicted on the Condominium Map of Campfire Mountain Homes, recorded at Reception No. 596751 in the Summit County Clerk and Recorders office on May 27, 1999 is hereby reconfigured as generally depicted in Exhibit B, attached.
- The Limited Common Element patio Repeal and Restatement. appurtenant to Unit 14 as depicted on the Condominium Map of Campfire Mountain Homes, recorded at Reception No. 596751 in the Summit County Clerk and Recorders office on May 27, 1999 is hereby reconfigured as generally depicted in Exhibit C, attached.





EXHIBIT B UNIT 11 DECK CONFIGURATION
