WELCOME TO LAKE FOREST! OBSERVING OUR RULES ENSURES THAT EVERYONE ENJOYS THEIR STAY. OWNERS ARE RESPONSIBLE FOR ENFORCEMENT OF RULES.

NOISE Please be sensitive of noise that may carry to adjoining units, next to, above or below you.

SMOKING Please refrain from smoking on the unit decks and patios. Take a walk and dispose of your cigarette butts in the trash not on property.

SNOW ARWARENESS AND REMOVAL Please be aware of your surroundings. We live in a high alpine environment.

- **Look Down** as you move around Lake Forest always be aware that there may be icy areas on our walkways, parking areas and steps and remember the conditions can change quickly with melting and new accumulations.
- **Look Up** at the roofs of Lake Forest that are notorious for the buildup of large icicles. These can be beautiful but also extremely dangerous. Avoid, if possible, walking under areas with ice build-ups.
- Snow accumulation on balconies: If you live on the second and third levels or Buildings A D or the top level of Building E & F please be considerate of the neighbors below you and take the time to remove snow buildup from you deck. As the days get sunnier and warmer the south facing Lake Forest decks are a wonderful place to sit and enjoy the sunshine. Dripping snow melt from above can ruin that peaceful enjoyment.

VEHICLES

For everyone's safety, the posted speed limit of 10 miles per hour is strictly enforced.

Vehicles are to be parked **only in designated parking areas.** (Not off the paved area or in front of buildings, entrances or garages).

Every unit had and assigned garage. These must be used for storage of any vehicle to be left for an extended period.

Oversize vehicles (trucks over 22 feet, boats, RV's, campers, buses and trailers) are not permitted in the parking lot overnight. The Dillon or Frisco marinas may have boat/trailer parking areas. Please contact them for more information.

PETS

Only owners may have a pet. Renters, tenants and guests are **not allowed** to have pets on the property.

Owners are limited to one pet unless specifically authorized by the Board in writing.

Owners are responsible for immediately picking up after their pets at all times.

Pet Pick-up bags are furnished at three locations within the complex.

All pets must be leashed. Frisco city ordinance is strictly enforced.

Pet relief areas are located in the natural areas at the far ends of the complex. Grassy area around hot tub building is for picnics and other people activities. This is not a pet relief area.

HOT TUBS

Hot tubs are available only during the posted hours at the spa; accessed by special keys provided by SRG Glass containers and food are not permitted in the hot tub area.

Replace the hot tub covers after use.

Adult supervision is required for all children in the hot tubs.

No pets are allowed in the hot tub area

GRILLING

Grilling is only permitted in the HOA designated grilling areas or on owner' decks when using an HOA approved electric grill.

Common area grills may be subject to seasonal closures.

TRASH/OTHER

The trash dumpster is located North of the hot tub area between buildings E & F. **Do NOT** throw plastic bag with recycling materials in receptacles – tear bag and dump contents and throw bag in dumpster.

This facility is for household trash only. no furniture or construction debris may be discarded

The Condo Association and its On-Site Manager are NOT responsible for the following items. If you have

problems with these items, call your rental agent or a service company.

Interior maintenance or repair

Kitchen appliance, hot water heater, furnace or fireplace lighting and operation

Clogged toilets

Keys for unit or garage

Electric, gas, water, cable TV, and telephone outages
