### V. OLD BUSINESS

#### A. 80 Mule Deer Stain Court

Deb Borel has tried to contact the owner by email and phone for six weeks. She sent a certified letter last week but has not heard back. The owner re-stained without the proper approvals and there have been three neighbor complaints about the color scheme. Further discussion was tabled until a response is received from the owner.

### B. 15 Raindance Trail

The owners filled out and submitted the incorrect paperwork yesterday. Jerry Westhoff, ARC Chair, has responded with what is needed for approval. Jonathan Lerner said they clarified in an email that their intention was to add bushes and landscaping and not

additional parking. The application is in process with the ARC and Deb Borel will keep the Board updated.

### C. 60 Mule Deer Screen

The owner requested approval but did not stain the screen to match the house. The natural wood color is, however, on the palette of approved colors and the board approved it.

# D. Deadfall

Summit Fire and EMS toured the common areas yesterday. There are 10-13 dead trees. There is a fire pit near the open space on Habitat, which should not be used. Web said the Fire Department might be willing to cut the trees as part of their training. The Association would be responsible for removing the wood or could approach the Boy Scouts. Matching grants are available for fire mitigation but there would still be a significant expense for hiring an arborist to cut down the trees.

### E. Barbecue

Web said the barbecue was a great success. Timberline has not yet sent the final invoice. The cost was around \$1,700 including the porta potties, which may be slightly discounted. There were about 150 attendees.
